Minutes

- 1. President Kaja Lotman welcomed everyone and declared the meeting open.
- **2.** Introducing new members

Section has 3 new members- Abisko National Park (SWE), Hamra National Park (SWE) and Mols Bjerge (DK) National Park.



3. Feedback from the Siggen seminar in May 2012

Council has proposed to change some of the member categories. It was discussed in the Council that if a member is in great debt, EUROPARC seizes membership. Nordic-Baltic section had also 4 members in debt according to the data received September 2012 (Denmark- 1, Norway- 4). Since mid of October members have paid the fee, but 1 Norwegian member (Setesdal Vesthei - Ryfylkeheiane Landscape Conservation Area) wishes to end its membership.

Czech section is planning to make their section wider by inviting Slovakia, Slovenia, Hungary and Austria to form Central-Europe section. Some countries are positive about the idea, some are not.

French section will elect a new president in the end of 2012. The section has had many debates over the merger issues as there are different positions.

4. Feedback from working groups

Transboundary working group held a meeting "TransParcNet 2012" on Finnish-Norwegian-Russian border in the Trilateral park Inari-Pasvik. Since 2009, the working group has yearly meetings. In 2013 the meeting will be in the Netherlands. The wish is to meet even more often and to have Council and the Directorate involved more in the working group activities and meetings. Also there is a big potential in getting new transboundary parks certified. Right now there are 19 certified protected areas of the 60 potential ones.

Health working group involves 2 sections- Nordic-Baltic and Atlantic Isles. Health has been an issue in the Federation since 2008. Two years later the working group made a road map. Working group has asked the Federation to work more on the health topic the next years in order to make a toolkit for managers on how to work with health benefits and to monitor them. Health working group can use already existing platform "Healthy people, healthy parks". Also some project ideas are under discussions. Next seminar on health issues will most probably be in 2014. The main point of the working groups and sections is to be more visible in the EUROPARC General Assembly.

5. Section's 10th anniversary

EUROPARC Nordic-Baltic section was formed in January 30th, 2003. Metsähallitus will host anniversary seminar in Finland, Nuuksio National Park May 28th-29th, 2013. The seminar will focus on strengthening the cooperation between three Nordic-Baltic protected area manager networks: EUROPARC Federation, Ramsar Nordic Baltic Wetlands Initiative NorBalWet and Nordic World Heritage Sites.

6. Presidency 2015-2017

Next hosting countries according to the rotation rules can either be Denmark, Iceland or Norway. It was proposed that further discussions will be made with Denmark.
